Cooperates with NBS by exchanging data on: air quality in the main cities, calculation of pollutant emissions in air from mobile sources, calculation of the emissions of the GHG from different sectors, etc.

Agency "Apele Moldovei"

Collecting and elaborating the "Water use" report which contants:

- water capture,
- water use,
- water use through the closed circuit system and consecutive,
- wastewater discharge,
- transport losses.

Agency "Apele Moldovei" submit the report to the NBS for publication and dissemination of the aggregated information.

State Hydrometeorological Service

SHS presents:

Key Climate Indicators like:

- air temperature (min., max., average),
- the amount of atmospheric precipitation (monthly, annual),
- Wind speed (min., max., average), duration of sunlight.

Collaboration with NBS consists in exchanging and dissemination of the information.

Dissemination of the information

- State of Environmental report (published on the web page of the MARDE, on <u>www.date.gov.md</u> portal),
- Natural resources and environmental in the Republic of Moldova (elaborated and published by BNS),
- Environmental indicators (published in the NBS web page),
- Reporting to the Convention (UNFCCC, Ozone Convention, CLRTAP etc.),
- Informational systems (Waste management, PRTR),
- Publishing data on governmental open data portal.
