















State of Environment Development Report (2019) Links with MAP Assessment processes and Indicators







From 2017 MED QSR to 2023 MED QSR:

Vision: An integrated DPSIR-based GES assessment, developed on consolidated and quality-assured monitoring data sets, reported and processed through an effective IMAP Info System that is interoperable with national and other regional monitoring and reporting networks.

- 1. Agreement level on the scale(s) of monitoring, assessment and reporting;
- 2. Agreement on necessary methodological tools and assessment criteria to allow and promote integrated assessment of GES per/among different EO;
- 3. Full implementation of IMAP-based national monitoring programmes;
- 4. SEIS-based IMAP Info System fully operational
- 5. Monitoring Protocols and Data Quality Assurance and Quality Control
- 6. Support and technical assistance to the Contracting Parties in relation to all the above areas;
- 7. Outreach to regional partners and communication and visibility strategy
- 8. Regular and effective regional cooperation (CORMONs)


